Review of Minutes for February 2019

Announcements – Megan DuBois, Cultural Arts Manager

- Megan distributed a list of 2019 Spotlight events that were funded in part by Commission on the Arts grants.
- Megan passed around a draft schedule for next season's Old Town Hall Performance Series (OTHPS). She hopes to have it ready for release in a few weeks.
- Megan said the Shoestring Theater Company is inviting Commission and Council members to be their guests at the May 4 performance of *Haint So*.

Old Business

ArtScreen - Jeff Seffens

- Jeff discussed the upcoming ArtScreen event, The Buddy Holly Story movie.

Public Art Committee (PAC) – Carol Caputo, Megan DuBois

Carol said the committee met last night and discussed the following -

- <u>The Peace Bird</u>, for Van Dyck Park The piece is not yet constructed. The foundation will be done soon. We will have a dedication ceremony when it's installed.
- The Girl with the Dog, for Old Town Square This piece is in the works.
- <u>New dog park</u> at the site of the former Westmore Elementary School This is way behind schedule. The committee is interested in creating a mosaic around the fountain.
- Paint Your Pet fundraiser at Paint Your Own Pottery (Deb's studio) See below.
- GMU Mural Brigade They are starting work for a 2020 event.
- <u>Community membership</u> The committee is discussing the idea of adding members of the community to the group.
- <u>Traffic Signal Box Painting</u> Megan said Cathy Salgado would like us to pursue this project. She's seen it done in other towns and said it's very effective.
- <u>Field trip</u> Sharon proposed a field trip to Dumbarton Oaks. It's close by and has wonderful sculpture and gardens.
- <u>Collaborations</u> The committee hopes to increase our collaboration with GMU and add additional groups, e.g., NoVA.

Development/Sponsorship updates - Pat Gallagher, Megan DuBois

- Pat G. said the committee received the updated donor database and is reviewing it.
- Pat G. said the committee is looking for a sponsor for Funday Monday.
- The OTHPS is approaching its 30th anniversary; the committee is working on ideas to celebrate the occasion.
- Megan said she has not heard from TD Bank; she will follow up with them.

The Ernst Center is a nice venue, but it's a little small for the band, it costs much more for the band to rent, and the audience doesn't seem to want to travel. She said this is a good example of why we should push for a large, city-based performance venue.
