#### **Spring Wave Parade**

Since the traditional Egg Hunt was canceled this year, we organized a fun "social distancing parade" called the Spring Wave Parade on Saturday, April 11. The goal of the parade was to bring joy to our community while following along with social distancing guidelines. Residents were encouraged to come out to their yards, front doors, porches and wave as the parade passed by. The parade included the Spring Bunny, Police and Fires departments and traveled over 30 miles around Fairfax City. This alternative event was very successful and we received so much great positive feedback from the community!











#### **Fairfax Fundayz**

We have started an online programing initiative on our Facebook page to keep people engaged while we are unable to interact with them in person! Social distancing does not mean disconnecting! Each day we provide a project, craft, game, workout, or some music for people to enjoy. These are all things that can be done at home with minimal supplies. We have recently started working with the Economic Development Authority to get fitness businesses in the City of Fairfax involved and promote their business while providing a good workout to residents for our "Thirty Thursday" Fairfax Funday where we encourage people to participate in a 30 minute workout. In addition to Fairfax Fundayz, we are working to keep up engagement on our Facebook page by posting fun trends and games for people to respond too. Things like "Pick 3" - "See a Pet, Post a Pet" "Parks and Rec Showdown" etc. They are all positive fun things that remind people of what our department offers.

#### **SHERWOOD PROGRAM UPDATE**

At this time, the Sherwood Center is closed until further notice and all classes, programs and lessons are cancelled. All of the preschool programs and the Sherwood Afterschool Program have been cancelled until the end of the school year. All refunds have been issued for these programs which was about \$20,000 and an additional \$80,000 in stopped payments through June. All spring break programs were also cancelled and refunded which resulted in a loss of approximately \$20,000. Plans are being made to safely open all of these programs again in the fall.

#### **SUMMER CAMP 2020**

As of April 22, the camp programs are planned to run as scheduled. While we know things are changing constantly, many contingency plans are being made. A big factor will be dependent on if we will have access to the schools this summer. Once we confirm if we will have access to the schools, we will be able to make more finalized decision on the programs. We are exploring creative ways to hold as many programs safely for children this summer. Field Trip planning has come to a halt as many places not currently open. While the City is on a hiring freeze, we are lucky that we have 50 staff members returning from last year that can work if needed. We currently have over 600 campers registered for traditional and specialty camps. While we have high hopes that the situation will be better and camps can run, we are also realistic about options that will prioritize safety in our community.

#### March / April Program News - COVID UPDATE

Due to COVID-19 we have canceled all our trips, classes and senior center activities through June 10. Our senior GL accounts were refunded \$11,930 and the Green Acres GL accounts refunded \$1,265.83 since the start of the closures with pending credits to be refunded when available through active net.

Many staff changes came about this past month. On April 16 we had to let go our temp staff to include Kathy Carter, trip chaperone/ on call senior center assistant and Kira Urano, assistant senior center coordinator who worked the afternoon shift at the senior center. Jann Weltman, after 7 years of working at Green Acres in the senior center, also retired from her position as Community Program and Senior Center Assistant Coordinator.

One of the first decisions the Department made was to cancel the senior center St Pat's Day Potluck on March 13, programs and classes soon followed.

Open House and Older American's Month Celebrated at the Senior Center in May is canceled this year along with the decision from the Northern Virginia Senior Olympics Executive Committee to cancel the games in September 12-27, 2020.



During this time we have also been busy:

Creating senior call lists to disturb to staff members to make senior wellness calls each week. Implementing the seniors calls each week to access any needs seniors may have and just to chat -which for a many seniors is a very a important connection to have in this time of isolation. Communications blasts have been sent out to seniors through active net to stay informed with programs. Creating reports to determine loss revenues and for classes and trips. Spending time following up with community members to cancel and reschedule drop in programs and activities. Working on Fall brochure- *if we decide to move forward with Fall programs*. Organizing storage room behind front desk and filing last fiscal year. On line trainings. Lastly new virtual staff meetings and providing committee information as needed to the City during the closure.

Starting Sunday, March 15th, 2020, Operations began cancelling rentals that would take place any time between March 16th and June 10th. During this timeframe, Operations has cancelled or rescheduled just over 170 permits. This does not take into consideration the number of dates that could be booked on one permit. Many Repeat Renters would have a full year's worth of rentals on one permit, meaning if a permit was adjusted (portions cancelled or rescheduled), it could mean that over 30 dates could have been cancelled and refunded for. To date, Operations has a total loss in revenue of \$198,772. This number will continue to grow as time goes on due to concerns from our customers with COVID-19.

Moving forward, Operations may need to take into account the size of events that are to take place even after the Executive Order has been lifted. If we are to follow social distancing parameters, we may not be able to host large events that have already booked with us. An event that may be planning for 300 guests, theater style seating, may now only be able to accommodate 42 guests seated theater style. This will drastically affect how we can host events, the number of people we can accommodate and the price point in which we charge. The fee structure to host an event in a 5,000 sq. ft. room accounts for maximum capacities in guest count. We may need to consider a drop in price points for a space that could previously host 300+ guests, can now only accommodate +/- 40 guests.
