SUMMER CAMP 2020 CANCELLED

Unfortunately, due to the COVID-19 situation, the very difficult decision was made to cancel all of the 2020 summer camp programs. It was just to difficult to offer these programs in a safe manner, and without the use of FCPS, we did not have the capacity to operate as needed. There were just over 600 campers enrolled at the time of cancellation. Feedback from parents has so far been understanding and respectful of our decision and we have begun the process of refunding everyone. We are diligently reviewing if/when we will be able to open safely for any programs and classes. The following message was sent out:

Good Afternoon City of Fairfax Camp Families,

We have been working very hard over the past few months to make a decision on camps for the 2020 summer. After vigilant consultation with local health officials, school representatives, other regional recreation providers and local government officials, the decision was made to cancel ALL 2020 City of Fairfax summer camp programs. With the health and safety of the entire community including campers and staff as the City of Fairfax's top priority, we felt there were too many challenges to ensure we run camps safely this summer. We fully recognize that this difficult decision will be disappointing to families but hope that you are understanding. Please know that we did not make this decision lightly and we are deeply saddened that there will be no summer camp offered this year.

All families will receive a full refund/credit (see options below):

- **REFUND:** No further action required- you will be automatically issued a refund back to the same credit card you make your payments.
- O Make sure your credit card is saved on your campdoc.com file and the 'organization permission' button is selected.

CREDIT ON ACCOUNT FOR 2021: If you prefer to have the fees you have already paid for 2020 be held as a credit for 2021 - you will receive a 5% bonus credit if you choose this option! We will do our best process these refunds as soon as possible and we appreciate your patience. Insurance plans are purchased directly through Campdoc, so please contact them if you have any questions on that. Many of our third party camp partners will be offering virtual options will be sent out very soon as well.

We value all of our camp families and recognize that our camp programs are vital part of our community. We look forward to having camp again in 2021, and by registering this year you will receive priority registration at that time. Information will be sent out at the beginning of the new year.

Now Accepting Registrations for Preschool 2020/2021!

With high hopes that the Sherwood Center will be able to open safely for fall, we now have registration available for preschool programs for the 2020/2021 School Year. These programs will include Little School for ages 3-5yrs and Mi Chu Chu Tren Spanish Immersion Preschool for ages 2yrs and six months to four years. All programs have a two day, three day or five day option available. These are VA State Child Care licensed preschools and financial assistance is available for City of Fairfax residents in need. Registration is done through Campdoc.com.

2. Spring Permits:

A. 8 groups paid a total of \$2,585.50

B. 2 of the groups will not be able to use the fields because their season ends in May

C. There is still a chance that the remaining 6 groups could get to use the field in July

D. Once you are over 3 uses you pay the same amount if you use the field 3 times or 30 times in a season. Technically the permits and fees issued for the 6 remaining groups could still apply if they play 3 or more times by the end of July

4. Stats for the season

A. \$2,550.00 Total Revenue. Early March tournament. No refund needed.

Given the current state of the pandemic, our department has now been tasked with cancelling all rentals at our indoor facilities through the end of July. Additionally, all pavilions will only be open for rentals starting June 15th and will be limited to 50 or less through Phase 1.

With these additional cancellations, along with renters that have concerns over the pandemic and have chosen to cancel on their own accord, we have now cancelled or rescheduled 202 permits. Here is the breakdown in loss of revenue for all indoor and outdoor rental facilities:
