May 19, 2016 Electoral Board Meeting Minutes



Call to Order

The meeting was called to order at 10:03 a.m. The Secretary asked that items in the original agenda be taken in a different order to address several items that could be handled expeditiously.

2. Donuts for Officers of Election

The Chairman indicated he had found a potential supplier of donuts for the officers of election for Election Day; it appears Shoppers Warehouse located in the City of Fairfax has donuts for a significantly reduced price as compared to Dunkin Donuts. The Chairman will explore the option of using Shoppers.

Status/Risk Assessment

The Secretary reported the risk assessment was in work.

- 4. Approval of the May 5, 2016 Electoral Board Meeting Minutes
 The Vice Chairman moved that the minutes for the May 5, 2016 meeting be accepted as written. The motion was seconded by the Chairman and passed unanimously.
- 5. Officer of Election applications

The General Registrar presented three potential officer of election (OEs) for consideration. After discussion, the Chairman moved and the Vice Chairman seconded a motion to approve Svetlana Koch, William Brown IV and Susan Olenchuk as officers of election. The Registrar will make the appropriate notification to the individuals.

- 6. Health and Wellness Fair Green Acres May 14, 2016
 The Secretary reported the Board has displayed voting equipment at the Health and Wellness Fair held at Green Acres on May 14, 2016. The Board thanked the General Registrar and staff for their efforts in setting up the equipment so it could be used.
 - a. Set-up lessons learned:
 - i. Various Board members offered suggestions to improve such presentations in the future; a table cloth to cover the support platform; a banner with Office of Election signage (approximately 5' x 2.5'); and a collapsible screen with Office of Elections signage.
 - ii. Glitter...a package of 'glitter' was placed in the package which contained sample ballots when the equipment was packed at the end of the event. The glitter contaminated the ballots and required the General Registrar staff to remove the material from the ballots to prevent damage to the scanner.

- b. The Board asked the General Registrar to investigate the procurement of a banner and/or screen which could be used at such events in the future. The General Registrar will report to the Board when the research is completed.

- a. The General Registrar and Electoral Board will continue to provide the above information when inquiries are received
- b. The General Registrar has prepared for the court a list of Electoral Board members and their party affiliations
- c. The General Registrar has prepared for the court a list of officers of election by precinct (with Chief and Assistant Chief identified) and their corresponding party affiliation
- d. The General Registrar and Electoral Board are awaiting specific direction from the court
