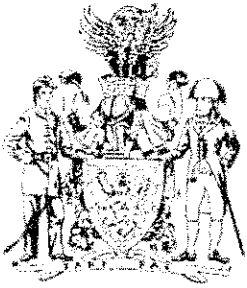
**APPROVAL OF MINUTES MAY 23, 2017 ELECTORAL BOARD MEETING**

The Chairman moved that the minutes of the May 23, 2017 EB meeting be approved as written. The Vice Chairman seconded the motion and it was passed unanimously.

**GENERAL REGISTRAR/DIRECTOR OF ELECTIONS REPORT AND UPDATE.**

The General Registrar provide the EB with a review of recent activities and updates related to the Primary Election to be held on Tuesday June 13, 2017.

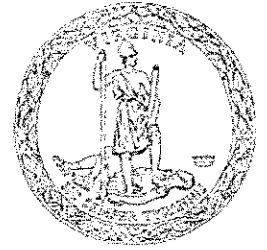
- Absentee Voting numbers: A handout was provided that detailed the numbers; of note 89 voters had been cast votes for Democrat candidates and 21 voters had cast votes for Republican candidates.
- OE applications/vetting: No new applications had been received the past two weeks
- Precinct to Registrar Communications: The General Registrar reported land-line phones and mobile phones would be used and was satisfied all communications needs had been met.
- Election Night Supply Return: The processes developed over the past two elections have proved superior and will be adopted again. It was noted that the post office needed to be visited at 4:45 p.m. on June 13, 2017 to obtain any ballots received; the EB will work with the General Registrar to ensure
- Party or Neutral observer requests: No requests have been received. It was noted candidates could observe consistent with the Code of Virginia and party chairs could still issue appropriate authorizations.
- Review contract from DemTech (pollbooks): The General Registrar distributed a copy of the proposed DemTech contract. City contracting has the document and will address it in detail. All localities using the DemTech pollbook are now going through the same contractual review.
- June 14-16 Activity: The General Registrar and the EB discussed activity for the Canvass; based on past experience, the Canvass will begin at 10:00 a.m. on Wednesday June 14. It is believed most of the required actions will be completed on the 14<sup>th</sup> and the only remaining issue will be voters having until Friday June 16, 2017 at 12:00 p.m. to submit required identification for ID ONLY

#### Voting Issues

The Secretary referred to the agenda and gave a quick review of the numbers articles that have recently appeared in the press; the review covered the following items:

- Voter fraud
- More news coverage of alleged illegal voting; several news articles shared.
- More news coverage of alleged Russian interference with 2016 Presidential Election
- Recent government disclosure of IT related breaches of voting related equipment
- Registration equipment; several news articles shared.
- Voting equipment; several news articles shared.
- ELECT and VERIS actions and official position on voting system integrity

Discussion of these items followed. As there has been considerable attention given to the reported interaction between DHS and many states concerning voting integrity, the General Registrar was tasked with contacting ELECT to determine what if anything Virginia did when offered "help" from DHS to provide assistance. The General Registrar will report her findings to the EB.

Note: U.S. Elections Systems have been designated critical infrastructure. There are 16 designated critical infrastructure sectors [See Presidential Policy Directive 21 (PPD-21) which fall under the National Infrastructure Protection Plan (NIPP); DHA has designed U.S Election systems as Critical Infrastructure under the critical infrastructure sector, "Government Facilities."]

- General Registrar and EB coordinated communications strategy

The EB and General Registrar discussed and agreed on a communications strategy that will be used to ensure the voters of the City of Fairfax that the voting system used in the City is secure and they can be confident in the integrity of the system.

#### **CLOSED SESSION – PERSONNEL MATTER**

At 12:02 p.m. the Secretary moved that the Electoral Board of the City of Fairfax convene in closed session pursuant to Section 2.2-3711 (A)(1) of the Code of Virginia for the "[d]iscussion, consideration or interviews of prospective candidates for employment; assignment, appointment, promotion, performance, demotion, salaries, disciplining or resignation of specific public officers, appointees or employees of any public body; ...." The motion was seconded by the Chairman and approved unanimously.

Upon a motion made by the Secretary at 12:22 p.m. , seconded by the Chairman, and passed by unanimous vote of the Electoral Board, the Electoral Board reconvened in open session.
