1. Call to Order

4. Presentations/Introductions

Presentation of Department Re-Accreditation by Brianne Baglini. See attached presentation.

5. New Business

a) Facility Re-Opening Plans

Ms. Salgado reported the City is moving quickly in response to the Governor's lifting of several COVID restrictions. Sherwood Community Center will reopen on June 1 for both regular programming and hours open to the public. Exact hours have not yet been determined, but plan to be six days a week. Green Acres will reopen later this summer after summer camps have ended. Senior programming will be held over the summer at Sherwood, Blenheim, and Old Town Hall. City Hall will remain open to the public by appointment only for the time being. Mayor and City Council will begin hybrid meetings starting in mid-June. PRAB can anticipate beginning hybrid meetings starting in July.

Ms. Luckabaugh asked how these changes will affect rentals.

Ms. Salgado responded that staff is currently inundated with facility rental requests and pavilion reservations. Staff is working to hire several CSR's to accommodate the reopening the facilities. Ms. Salgado is working and communicating with several local jurisdictions on reopening plans and looking at the public vaccination rate.

b) American Recovery Plan

Ms. Salgado shared the City has still not received any definitive word from the State or Federal Government regarding what share the City will be receiving. Virginia is unique in that is has 43 cities within the state that are treated differently than the actual states and counties. The City doesn't know what the low or high end dollar amount they could be receiving is. She will share more as information becomes available.

6. Old Business

a) FY22 Budget Adopted

Ms. Salgado shared the FY22 budget was adopted last week. Good news there were not cuts and the department got everything requested. Additionally, the trail lighting project underpass at Old Lee Highway was put back in and approved. Work will begin after July 1, 2021. The department's brochure, Parks and Rec Connected will be printed and mailed to customer's and residents starting in the Fall instead of being online only as was such during the COVID closures. The department is working to get back to being fully staffed again.

b) Community Center - Update

Ms. Salgado reported Blue Heron Leadership Group has been hired as a consultant firm to aid the City through the Community Center project. A kick-off meeting is scheduled for the beginning of June with staff. The firm will be putting together a public engagement plan for later this fall that will include PRAB. Ms. Salgado would like them to attend the July PRAB meeting to begin communication with PRAB. The project lead from is James Patterson who happens to be a City resident.

Vice Chair Knapp asked Chair Ross is she was able to speak with Mayor Meyer about PRAB's desire to be more involved with the project.

Chair Ross responded she be sure to connect with him and discuss PRAB's intentions after the meeting.

Ms. Salgado shared that there will be a lot of opportunity for public outreach this fall and hopes to be able to do so safely in person.

c) GST M/CC Work Session – Report out on 4/20 meeting

Ms. Salgado and Chair Ross shared a lot of the information received by Mayor and City Council was positive. They are pleased with the refinements made and the reduced footprint due to the redesign. These positive changes are all thanks to reengaging the trail designer. The tree impact is decreased by approximately 100 trees. Mayor and City Council were briefed on the trail realignment by Route 123 and the architectural designs presented to PRAB at the April meeting. Mayor and City Council encouraged staff to continue as planned. Staff is anticipating the 65% plans to be completed in June. The plans will then be reviewed by Community Development and Planning, Public Works and VDOT. The sections of trail at Stafford Drive and Ranger Road are being put back in.

Ms. Cipriano asked if the Ranger Road bridge will be upgraded to adequate width.

Ms. Salgado responded that two options are under review. The first is to build a new bridge to support the build of the trail. The second being to put in a temporary bridge.

Ms. Luckabaugh asked if the community groups that had previously expressed concerns were happy with the direction of the trail due to the changes. Also, if building costs will/are being impacted?

Ms. Salgado responded that yes, the current supply problems and price could impact the project, but it is unknown how long they will last. It is very possible these issues will be resolved long before building begins. As far as the community groups she doesn't know if they are happy. But they may be happier

with the direction of the project to reduce the footprint and tree impact thanks to the redesign.

d) Discussion on Parks Bond

Chair Ross distributed via email prior to the meeting a draft resolution collaborated on with Vice Chair Knapp.

Vice Chair Knapp shared he received good constructive feedback on the document.

Chair Ross reported that she received a call from Mayor Meyer who became concerned when he heard about PRAB discussing park bonds, because the CIP was just passed. She shared that she recognizes the new CIP in process and hopes funding comes through, but there is a history of Parks and Recreation projects being passed over resulting in the parks showing their age. She feels the conversation went well and was positive.

Chair Ross opened the conversation to the floor.

Ms. Gibson answered that she shared several comments via the group email thread. She feels the document would be make stronger by adding documentation with pictures and number comparison. In response to other's comments concerning the documentations language using "whereas" is how formal resolutions are written.

Ms. Cipriano asked for clarification on what the purpose of the document is. Is it something Mayor and City Council will use to proceed with a park bond, or is it more of a letter trying to show PRAB's position? Will it be a public document? The language is very formal and can be confusing, but it also has a lot of good points. He agrees with Ms. Gibson on the importance of adding pictures and numbers as supporting documentation.

Chair Ross deferred to Vice Chair Knapp on the process of resolutions. Vice Chair Knapp responded that PRAB has only ever created a resolution a couple of times for matters that are of utmost importance and urgency. A decision needs to be made on how this is portrayed to Mayor and City Council. It could be a resolution such as this or a letter. However, neither are going to be enough. It is going to require repeated active efforts over time from every member of PRAB.

Ms. Gallagher suggested Mayor and Council could be concerned about the idea of a park bond due to a disconnect. They may only see the parks from a higher award-winning level unlike PRAB who sees the details, age and declining amenities.

Chair Ross responded that she is confident Mayor Meyer understands and sees the parks needs. She attributes his concern and reaction more to the timing of it all with CIP having just been passed. However, some Councilmembers aren't aware of the declining state of the parks and don't understand why PRAB would push for a park bond when the Community Center project is just now getting

started back up. They may feel PRAB is asking for too much at once, not realizing how many projects have been deferred year after year.

Ms. Rodgers-Rickert responded that she agrees with Chair Ross and that a big part of proceeding needs to be educating City Council and the public on what exactly the parks do need and that they can have both a new community center and updated parks for a reasonable price. She suggested adding a cover letter with the resolution to educate the reader on the need and purpose of it to help pull it all together. She is concerned about other projects coming down the pike that may need or require a bond.

Chair Ross shared she'd like to continue working on the draft resolution, receive additional feedback so that at the June meeting it can be discussed and potentially adopted.

Ms. Luckabaugh expressed concern over the timing of it all. If PRAB adopts in June and presents to Mayor and Council in July it has potential to lose all momentum during the August break. She suggests either speeding up revising and adopting to be completed by the end of this month. Or waiting until after the break and presenting in September.

Chair Ross responded she'd like to proceed with revising and adopting at the June meeting.

9. Stakeholder Updates

a) School Board - Jon Buttram

Shared the Principal at Providence Elementary School, Dan Phillips is out on emergency medical leave. The interim Principal is Linda Shannon. At the end of the school year the current Fairfax High School Principal is leaving and moving out of the area. Fairfax County Public Schools has an action plan in place to find a replacement. Currently schools are running a hybrid learning system with 40% of students in the classroom four days a week. The goal for the fall is to start with students in the classroom five days a week with athletic programs running at prepandemic status.

b) Planning Commission – Mark Angres, PC Chair

Shared at the Commission's Monday meeting they heard a preapplication briefing on a proposed project located in the wooded area next to the City's History Museum where the owner would like to build eight townhomes. The land has multiple challenges including being in both a floodplain and resource protection area. The City Council will hold a work session to discuss it further in June. The Commission is working on a Small Area Plan for Kamp Washington and the first public meeting to discuss will be held in June.

e) Commission on the Arts - Pat Gallagher

Shared Tuesday will be their May meeting, where typically they give awards in person at an Old Town Hall Performance Series event but have opted to do so virtually this year. In June they will be looking over revisions for their grant guidelines.

f) NOVA Parks - Brian Knapp

Shared NOVA Parks next meeting is scheduled for next week and a big agenda item is the approval of their next budget. Mark Chandler, the other City of Fairfax Representative on NOVA Parks is heading up a new strategic planning committee, which only done once every 10 years. The last big project planned by the previous committee is nearing completion a premier outdoor climbing course at Upton Hill in Arlington. On Sunday he gets to attend the dedication of the national memorial to American suffragists located at Occoquan Regional Park. Lastly, NOVA Parks is also struggling with decisions on when and how to reopen parks and amenities. They are leaning towards opening pools for the summer season.

Mr. Cipriano reported Thaiss Park still has mud issues after it rains and would appreciate staff correcting the issue.


