Meet the 2022 Women of Influence

Longtime residents Hildie Carney and Carolyn Sutterfield have lived life connected for decades by investing in the past, nurturing the present, and planning for the future — and in recognition, the Commission for Women has named them the 2022 Women of Influence.

A Country Club Hills resident since 1965, Carney started from the ground up, with decades-long memberships in the Old Lee Hills and Fairfax Ferns garden clubs. Her love of history and preservation led her to serve on Historic Fairfax City, Inc. for decades (most recently as its

president), and was one of “The Five” who encouraged the city to acquire the Historic Blenheim house and the surrounding land. From her living room window, she can see the Civil War Interpretive Center, and she often gives guided tours of the historic, one-of-a-kind house.

The past and the present come together in her management of Kitty Pozer Garden in Old Town Square. She served on numerous boards and commissions, including the Commission for Women, Board of Architectural Review, Festival of Lights and Carols Committee, and Independence Day Celebration Committee.

She also served for 14 years as an assistant to feminist icon Betty Friedan, who spoke at a Commission for Women event in 1989.

BEHIND THE BADGE

Fairfax City Police Department Chief’s Advisory Council

The Fairfax City Police Department Chief’s Advisory Council meets monthly to discuss issues of concern. Members provide their views on public safety and law enforcement issues directly to the police department.

“Public safety is a partnership, and I believe the CAC is one opportunity that community members have to actively engage with the police department to help provide better quality of life for all residents in the city,” said Police Chief Erin Schaible.

Recent topics of interest include how to protect yourself from mail and electronic fraud, scams targeting older adults, current crime trends, police training, legal changes, traffic concerns, and general safety concerns.

Information gleaned from CAC meetings is communicated to police personnel, and officers are tasked with action items related to the topic. For example, if there is concern from a particular community about speeding or not stopping at stop signs, extra patrols will be deployed to those locations. The department’s public information officer and the community services division disseminate educational outreach and coordinate targeted enforcement efforts as needed.

Schaible has been working to increase the diversity of the CAC and the communities represented. New members include students from George Mason University and Fairfax HS and representatives from the faith community. “Our goal is to try to have as much diversity as possible to ensure we hear from as many perspectives and communities as possible,” said Schaible.

ADOPTION OF THE AGENDA

- Approved, unanimously, the adoption of the agenda.

CONSENT AGENDA

- Approved, unanimously, consideration of a resolution to endorse the city's application to the Transportation Planning Board's Regional Roadway Safety Program.
- Approved, 4-2, introduction of an ordinance amending City Code Chapter 90 (Taxation) to add a new Article XIII pertaining to a new local disposable plastic bag tax. Further moved to waive the first reading, and to set the public hearing on the proposed ordinance for March 22, 2022. *(In favor: Councilmembers Lim, Miller, Ross, and Stehle. Opposed: Councilmembers Harmon and Yi.)*

PUBLIC HEARINGS

- Approved, 4-3, based on the public convenience, welfare and good zoning practice, with respect to rezoning application filed for the premises of the Breezeway Motel, 10829 Fairfax Blvd., 10807 Cedar Ave., 3937 Walnut St., 3930 Oak St., 3932 Oak Street, 3934 Oak St., the City Council approved rezoning application Z-18-00539 to rezone the subject property from CR Commercial Retail, RMF Multifamily, and RH Residential High to PDM Planned Development-Mixed Use with Architectural Control Overlay District (ACOD) to remain and approval of the Master Development Plan with modifications and commitments, which has been prepared and submitted by the applicant. *(In favor: Councilmembers Harmon, Ross, and Stehle; and Mayor Meyer. Opposed: Councilmembers Lim, Miller, and Yi.)*
- Approved, 4-3, the request for a Major Certificate of Appropriateness for 40 townhouses, 20 condominiums, and a future commercial development, and site improvements on the premises of the Breezeway Motel, 10829 Fairfax Blvd., 10807 Cedar Ave., 3937 Walnut St., 3932 Oak St., and 3934 Oak St, subject to conditions (as may be amended by City Council). *(In favor: Councilmembers Harmon, Ross, and Stehle; and Mayor Meyer. Opposed: Councilmembers Lim, Miller, and Yi.)*
- Public hearing on the proposed FY23 budget. (No action. Budget adoption scheduled for May 3, 2022.)
- Approved, unanimously, a supplemental appropriation resolution for \$900,000 to fund the purchase of real property located at 10251 Main St. and 10324 Sager Ave., and comprising in the aggregate about 2.7 acres.

- Approved, unanimously, to adopt a resolution in support of the United Nations Convention on the elimination of all forms of discrimination against women.

Apply for Stormwater Utility Fee Credits

Fairfax City established a stormwater utility to provide a stable, adequate, flexible, and equitable source of stormwater management funding. The stormwater utility credit program was developed in conjunction with the utility ordinance. The credit program provides a variety of options for property owners to apply for credits to reduce their stormwater utility fee. Credits are available for stormwater management facilities that are in good condition, regardless of their age. The program also includes six non-structural activity-based options to earn credit.

The creditable activities and crediting calculations have been developed so that all types of property owners can participate. The purpose of this program is to encourage participation in stormwater management and improve stormwater characteristics in the city. This program will help meet minimum control measures required by the city’s Municipal Separate Storm Sewer System (MS4) permit.

A menu of non-structural practices is available to city property owners for potential

SWU fee credit. These opportunities include urban tree canopy expansion, a no-fertilizer pledge, Adopt-A-Stream litter and invasive species removal, and a storm drain marking and monitoring program. The fee credits based on non-structural practices apply for between one and three years, depending on the practice.

SWU fee credits are available for the installation and continuing use, operating and maintenance of an approved, privately owned Best Management Practice (BMP). The fee credits for structural practices apply for three years. BMP examples include detention ponds, underground detention vaults, bioretention basins (rain gardens) and pervious pavement.

- BMPs constructed before 2014 are referred to as “Legacy BMPs”
- All BMPs constructed in 2014 and later are referred to as “New BMPs”

Property owners and organizations may apply for multiple credits for their respective properties from the menu of available structural and non-structural SWU fee credits. SWU fee credits may be earned cumulatively, with no set maximum percentage, with the exception that cumulative SWU fee credits will not preclude each billed property from being charged at least one Billing Unit (BU) per year.

“I love the city and want it to stay as wonderful as it is,” she said. “I’m not a visionary. I live for today. I can do a lot of stuff today and can shake up things. To look [ahead] is a gift.”

Sutterfield, a professional writer and editor who has lived in the city since 1988, was galvanized while editing a journal for the Association of Science and Technology Centers about how communities, municipalities, and associations were working to meet the challenges of aging populations. She also was deeply affected while helping family members navigate their last years of life and end-of-life-planning.

The Mosby Woods resident represents the city on the regional Fairfax Area Commission on Aging (as chair and, currently, as secretary) and has served on the City of Fairfax Human Services Committee and Mayor’s Committee on Housing for the City of Fairfax. She also served as chair of the Mosby Woods Village Steering Committee.

“I never had a hometown. I was blessed coming here,” Sutterfield said. “I want ‘live life connected’ to apply at all ages so that people can still be contributing actively to their community.”

She said, “I want people to feel connected to Fairfax City as long as they live here and have an opportunity to participate in that way — even if it’s not in the same house, but to be active and involved and be surrounded by friends of all ages.”

Recycle Right. Know Before You Throw!

When preparing materials for recycling collection, it is important that you know before you throw and place only recyclable materials in the bin. So, what is recyclable in Fairfax City's curbside recycling program?

Acceptable materials include aluminum and steel cans, mixed paper, cardboard, and plastic bottles, tubs, and jugs. Other materials may be accepted in drop-off programs or other municipal programs but are not accepted via Fairfax City curbside recycling collection.

There are many household items that do not belong in the recycling bin. The recycling industry calls this "wishful recycling." Material such as plastic bags, glass, food residue, Styrofoam, plastic takeout cups and containers, batteries, food wrappers, shredded paper, and hoses and cables contaminate recyclable material, damage sorting machinery, and



add time and cost to the process.

Recycling right means placing only empty, clean, and dry accepted materials loose in your recycling bin. If you are unsure about the recyclability of an item, please reference the City of Fairfax recycling guide, or place it in the trash. Consider ways to reduce your trash, and reuse items in other ways. Recycle whenever possible — and when in doubt, leave it out.

If we all recycle right, we help local recycling centers successfully prepare recyclable material for manufacturers to purchase to make into new products. Recycling right preserves our natural environment and resources, supports local industries, reduces pollution and greenhouse gas emissions, and creates a circular economy for our discarded recyclables. Together we can keep our community clean and healthy.
