## 7. DIRECTOR OF ELECTIONS/GENERAL REGISTRAR (DE/GR) REPORT

The DE/GR provided an update to the Electoral Board on preparation for the Democrat Party primary election which take place on June 20, 2023

## a. PRIMARY ELECTION:

- i. BALLOT ORDER The order has been placed for 200% of voters.
- ii. EQUIPMENT DELIVERY DATE AND TIME All voting equipment with the exception of PCT 2 and PCT 4 will be deployed on Friday, June 16, 2023. Equipment for PCT 2 and PCT 4 will be deployed on June 19, 2023.
- iii. CITY PROJECTS A listing of City projects that will impact the demographics of the various precincts was provided to the Board; the DE/GR will monitor these projects as it is estimated that by 2025 there may need to be established an additional precinct in the City.
