## Interest-Free Loans Available for Tax Payments

## COUNCIL ACTIONS OF SEPT. 10, 2024

### ACTION TAKEN FOLLOWING CLOSED MEETING

- City Council approved hiring Jason Kozak as human resources director.

## Fairfax City Recycling Audit Reveals Less Waste, More Recyclable Material

A recent audit found Fairfax City's curbside recycling program contains less contamination than the national average. The audit showed a reduction in the contamination rate from 11.4% in 2023 to 7% in 2024. This means that 93% of the material collected was recyclable and not trash destined for a landfill. In comparison, the national average for recycling contamination is estimated to be 17%, with some areas experiencing rates as high as 40%!

"This achievement is a testament to the hard work of our team and the ongoing commitment of our residents to recycle right," said Melissa Pennett, environmental sustainability specialist for Fairfax City. "Working with our community, we are improving our sustainability efforts and our cost efficiency."

The annual audit was conducted in August at the city's contracted recycling facility that sorts and sells the city's recyclable material and consisted of sorting and weighing an approximately 250-300-pound sample from an inbound recycling truck over a two-week period.

The material composition percentages from the audit are used to estimate the monthly commodity pricing calculations. The recycling processing fees are directly associated to the amount of contamination (or trash) in the recycling stream. By conducting these annual audits, the city has proven it has reduced trash in the recycling stream and improved the cost effectiveness of recycling.

After the 2023 audit showed improvements in the quality of collected material during the previous year, Fairfax City's recycling costs were reduced by an average of 43%. With the outstanding results from the 2024 audit, the city anti-

pates even further cost savings.

Items accepted in Fairfax City's curbside recycling program include paper; cardboard; plastic bottles, tubs, and jugs; and metal cans and tins. All material should be placed in the bin loose, clean, and dry. No bags. Glass should be taken to a purple container or placed in the trash. *Info: fairfaxva.gov/recycling*

# FEEDBACK SOUGHT! Get Fairfax City Moving

Let us know which proposed transportation projects should get the green light

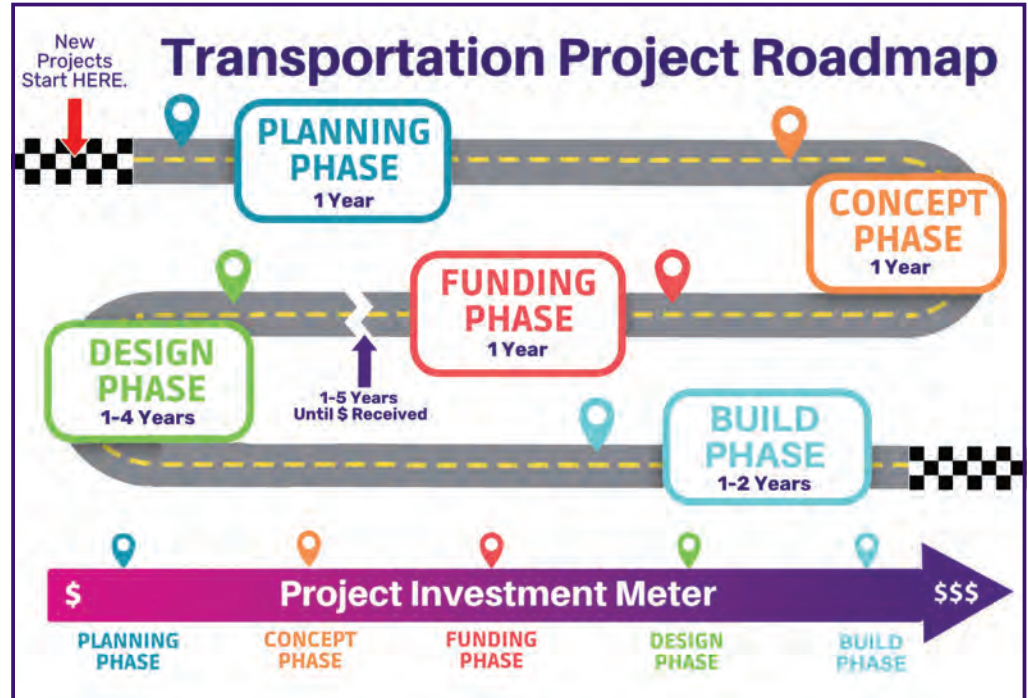
On Oct. 8, the city's transportation planners presented City Council with a list of projects eligible for outside funding from regional, state, and federal sources. If the projects are adopted by the council, transportation staff will begin developing conceptual plans for each project with the goal of pursuing funding within the next two years.

The funding is available to projects that meet certain criteria, but applying for the funding does not guarantee a project will be funded. Projects that are awarded funding would be developed further and built six to eight years from now.

The projects proposed in the FY2026-27 Two-Year Transportation Plan balance local and regional transportation needs, improve connectivity, and facilitate livability.

### Proposed projects include:

1. **Fairfax Circle Intersection Evaluation**
2. **Main Street/Lyndhurst Drive/Trapp Road Intersection Concept Development**
3. **Bicycle Route Wayfinding Plan + Implementation**
4. **Vienna Metrorail Station North Side Improvements (with WMATA)**
5. **Residential Sidewalk Feasibility**



## Which projects should be placed at the starting line?

HERE'S WHAT YOU NEED TO KNOW...

1. Transportation projects can take anywhere from 5-10 years from plan to build depending on project and funding source.
2. About 20 active projects are at various phases along the road at any given time. New projects are added to the starting lineup every two years.
3. It's critical that we identify the right projects to put on the road before resources are spent.

We've identified a list of priority projects and now we need **YOUR INPUT** to help determine if these are the right projects to put on the road next!

Once the list of proposed projects is adopted in the Two-Year Transportation Program, high-level conceptual plans for each project will be developed. The community will have another opportunity to evaluate the projects before City Council votes to submit these projects for funding consideration.
