#### f. Ashby Pond

A discussion was held based upon Brian's (previously submitted) recommendations to city council. A motion to accept all of Brian's points was passed.

### g. Trails sub-committee

Douglas Stewart was added to the trails sub-committee via PRAB motion. Brian requested future copies of the sub-committee's meetings minutes be provided for PRAB review.
