1) Meeting called to Order Time: 7:00pm

2) Approval of Minutes:

- 3) Presentation on Senior Center and Senior Programs
 - a. Karen Bixler and Tom Faulkner gave a detailed report on the history, statistics, operations, and future goals of the Senior Center and Senior Programs.
 - b. Director McCarty commented on the tremendous work that Karen has done to grow the senior programs and that she's an incredibly valuable asset to the Parks and Recreation Department and City. PRAB members concurred with enthusiasm.

4) Old Business:

- a. Update on Stafford West and Providence Park
 - 1. Chairman Knapp informed PRAB of the public hearing on Tuesday, April 24 at 7:00pm at City Hall. Chairman Knapp encouraged all members of PRAB to attend.
 - 2. Chairman Knapp asked for approval from PRAB to send a final letter of support to the Council prior to the public hearing. PRAB approved.

b. Update on Trails Day

- 1. Mr. Harmon informed PRAB of the schedule of Events for June 2, 2007
- 2. The next and last Trails Day sub-committee meeting will be May 3, at 7:00 pm at the Auld Shebeen.
- 3. Press releases have been distributed.
- 4. Mr. Harmon will be updating the www.fairfaxtrailsday.com website.
- 5. Mrs. Nasjleti updated PRAB on the booth vendors.

c. Update on Budget

- 1. Chairman Knapp reported that the budget passed and the Youth/Teen Coordinator survived. The Van Dyck Concept Plan, Two Bridges and \$40,000 for Ratcliffe Park also survived. The sprayground never made it into the Captial Budget and the Strategic Plan was removed by Council.
- 2. Chairman Knapp also reported that First Fairfax was not discussed and not part of the approved FY08 budget.
- 3. Director McCarty gave some brief comments on the importance of what the Department received in this budget process.
- d. Update on Park Rules and Regulations Sub-Committee:
 - 1. Chairman Knapp informed PRAB that the Sub Committee held a meeting to outline the process for review and revision of the park rules. Each Sub-Committee member and the Director were assigned tasks and will meet once a month to accomplish the committees goals. The committee anticipates a draft of revisions to PRAB in the Fall.
 - 2. Chairman Knapp asked all members of PRAB to review the rules binder they were given and submit comments and suggestions to the Sub-Committee.
- e. School Use Agreement Update
 - 1. Chairman Knapp informed PRAB that a number of revisions were made to the School Use Agreement and Stalnaker Field Agreement.
 - 2. Chairman Knapp asked PRAB members to review the agreements and submit any comments to him by Monday, April 23, 2007.
 - 3. The agreement will be discussed at the joint School Board/PRAB meeting on May 7.

5) New Business:

- a. Fairfax Boulevard Update
 - 1. Director McCarty updated PRAB on the Fairfax Blvd. Master Plan process and presentation.
 - 2. Director McCarty informed PRAB that many residents and business owners identified trails, greenways, green technology, water

- preservation, walking and biking paths, gathering space, parks, and a community center as priorities (mentioned numerous times).
- 3. Director McCarty encouraged PRAB to use a similar public input process for the Concept Plan for Van Dyck and the future Strategic Plan.
- 4. Ms. Nasjleti also attended the presentation and was impressed but stressed concern over how the Plan would be implemented.
- 5. The next presentation from the consultant is due to Council in June.

b. Re-Cap of May Meeting Dates

- 1. The next meeting is a joint meeting with the School Board at 6 pm at City Hall on May 7, 2007.
- 2. The next official PRAB meeting is Thursday, May 10 at 7 pm at Green Acres.
