

Wastewater Lateral Repair & Replacement Program
Wastewater Lateral R&R Program

Phase 1

DRAFT August 2, 2016

OBJECTIVE

The City Wastewater Utility is to participate in reimbursement of lateral pipeline repairs and replacements within the Rights-of-Way (ROW) or City Wastewater Utility easements. Phase 1 is expected to be corrective in nature but prevention of pipeline failures using trenchless technology is also encouraged.

BUSINESS CONDITIONS

1. Homeowner and businesses are eligible. Homeowners and businesses must pay for all repairs and replacements, the City Wastewater Utility will reimburse eligible repairs and replacements.
 - » Activities to clean out root infestation or blockage are not eligible (Insurance with Dominion Virginia Power is recommended for this function).
 - » Repair of laterals on private property is not eligible but replacement of the lateral from the structure to the ROW is (replacement all the way to the wastewater main is highly encouraged however).
 - » Landscaping is not eligible for reimbursement.
2. The City Wastewater Utility will reimburse property owners for a portion of the work when repairs are in the ROW only and when replacements are of a physical nature installing or inserting new pipe.
3. When the existing lateral and water service line are in the same trench, relocation of the water service is eligible for reimbursement up to the maximum reimbursement allowed (See Reimbursement Allowance Table).
4. Repairs and Replacement must not be the result of property owner's abuse or fault.
5. Reimbursement for replacement is a one-time obligation of the City Wastewater Utility.
6. City will not be the responsible management entity. The property owner must provide the management and be fully responsible for selecting the private

contractor and for the quality of the work performed by the property owner's contractor.

7. Participants must follow Program Requirements:

- a. Demonstrate the existing condition for Preventive Trenchless Projects. Demonstrate existing condition and need for repair and/or replacement for Corrective Projects. Demonstrate via use of a closed circuit televised recording of the interior pipeline provided to the City for review. Verify the quantity of Work to be accomplished.
- b. Provide at least two private contractor proposals or quotations for the repair and/or replacement to the City Wastewater Utility for approval of the best proposal to assure balanced unit pricing and quality work.
- c. The property owner or private contractor must obtain necessary City Permits and related inspections.
- d. Agreement with private contractor must include a two-year warranty.

8. City will provide Program Description to local Contractors, Applicants and post on web.

9. City will collect horizontal and vertical control at a future date for purposes of GIS. Private contractor will collect and provide to City depth of pipe invert at the edge of easement or curb based upon a known surface reference point.

REIMBURSEMENT ALLOWANCE TABLE

Condition	%City/ %Owner	Maximum Reimbursement
1. Replace from the Main to the Building	100%/0%	\$5,000
2. Repair or replace in the ROW Only	50%/50%	\$5,000
3. Replace entire length on Private Property Only	25%/75%	\$2,500

Note: Public Works Director will decide if extenuating circumstances warrant different reimbursement percentages on a case-by-case basis.
